# Summary of Federal Funds - CARES ACT



- Coronavirus Aid, Relief, and Economic Security (CARES) Act Funding
  - Elementary and Secondary School Emergency Relief (ESSER I) - \$58,982
  - Governor's Emergency Education Relief (GEER I) - \$9,996
- Funding Dates: 3/13/2020 - 9/30/2022
- Funds used for early pandemic needs
  - Gloves and masks
  - Chromebooks for remote learning

# Summary of Federal Funds - CRRSA



- Coronavirus Response and Relief Supplemental Appropriations (CRRSA) Act
  - ESSER II - \$206,845
- Funding Dates: 3/13/2020 - 9/30/2023
- Funding used for hybrid instruction and return to the classroom
  - Monitors for staffing needs for remote instruction
  - Cleaning equipment/supplies
  - Polycarbonate barriers to promote separation in classrooms and cafeterias
  - Technology – Chromebooks and jet packs for internet access

# Summary of Federal Funds - American Rescue Plan (ARP)



On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). New York State has been allocated nearly \$9 billion in ARP Elementary and Secondary School Emergency Relief (ESSER) funds. These funds are focused on improving potential lasting pandemic impacts.

Irvington UFSD Allocation: \$464,238

- Funds may cover expenses through September 30, 2024
  - 20% of funds must be applied to assist with potential “learning loss”

# American Rescue Plan (ARP)



## Allowable Expense Categories

- Supplemental and enrichment instructional programs to address pandemic impacts and learning loss
- Safely returning to schools
- Maximizing in person instruction time
- Supporting early childhood education
- Purchasing educational technology
- Expanded Social Emotional Learning/Diversity Equity Inclusion Initiatives
- Facility and operational improvements geared toward improved health outcomes
- Other

# American Rescue Plan (ARP)

The original budget was required to be submitted to apply for the funds shortly after the announcement of the funds and before a full analysis of our needs could be completed. As the District priorities and needs came into more focus, we have made ongoing revisions to the ARP budget as the next slide will detail.
